AFFIDAVIT FOR PROBABLE CAUSE

I, Bridget A. Glaser, swear or affirm under penalty of perjury, that I am a Law Enforcement Officer with the Fort Wayne Police Department, and that:

Sometime during the period of time between the 3rd day of November, 2002 and the 29th day of April, 2009, in the County of Allen and in the State of Indiana, said defendant, Larry M. Gonzalez, being at least twenty-one (21) years of age, did perform or submit to deviate sexual conduct, with V.M., a child who was then under fourteen (14) years of age.

Sometime during the period of time between the 3rd day of November, 2002 and the 29th day of April, 2009, in the County of Allen and in the State of Indiana, said defendant, Larry M. Gonzalez, being at least twenty-one (21) years of age, did perform or submit to deviate sexual conduct, with V.M., a child who was then under fourteen (14) years of age.

Sometime during the period of time between the 3rd day of November, 2002 and the 29th day of April, 2009, in the County of Allen and in the State of Indiana, said defendant, Larry M. Gonzalez, did perform or submit to fondling or touching with V.M., a child who was then under fourteen (14) years of age, with the intent of arousing or satisfying the sexual desires of V.M. or Larry M. Gonzalez.

Sometime during the period of time between the 3rd day of November, 2002 and the 29th day of April, 2009, in the County of Allen and in the State of Indiana, said defendant, Larry M. Gonzalez, did perform or submit to fondling or touching with V.M., a child who was then under fourteen (14) years of age, with the intent of arousing or satisfying the sexual desires of V.M. or Larry M. Gonzalez.

The Defendant, Larry M. Gonzalez, is described as being a male, whose date of birth is 6/24/1957, Social Security Number [REDACTED], 5'09" tall, 185 lbs, Hair Color: BLK, Eye Color: BRN.

The affiant, Bridget A. Glaser, believes and has good cause to believe that the said Defendant Larry M. Gonzalez committed the aforesaid offense. The affiant, Bridget A. Glaser, bases her belief on the fact that On April 29, 2009, Ofc. Bobay was dispatched to [REDACTED] in reference to a child molest. Upon his arrival, Ofc. Bobay met with J.M. who reported that her 9-year-old daughter, V.M. (DOB 11/03/99), disclosed that J.M.'s live-in boyfriend (Larry Gonzalez) has been molesting V.M. for the past six years. J.M. advised that on Monday, April 27, 2009, V.M. told J.M. that J.M.'s boyfriend, Larry, puts his hands inside of V.M.'s pants and that he has also put his "winky", meaning penis, between her butt cheeks. V.M. also told her mother that Larry made her put her hands around his "winky" and go up and down with her hands. V.M. also reported that some white stuff came out of his "winky". J.M. stated that she told Larry that he needed to leave and he was no longer living with her.

V.M. was interviewed by Pat Smallwood at the Child Advocacy Center (CAC). Pat asked V.M. why she was there at the CAC. V.M. stated that it was because of something at home. Pat established with V.M. who exactly lives in the home with her. V.M. stated that currently her mom, J.M., her brother, [REDACTED] age 11, and herself live together. It was then determined that Larry moved out a short time ago. Pat asked who made Larry move out and V.M. responded that she and her mom did and it was because V.M. had been talking about things he had done to her. V.M.'s mom stated that Larry had to leave and V.M. stated that she really wanted him to leave as well.

Pat asked V.M. if she could tell her about those things. V.M. then stated that whenever she was sick or something that Larry would make her lay down in his bed and he would lay on top of her and stuff. V.M. stated that Larry would not let her get up off the bed. V.M. stated that he would get up off of her and she would try to get up off the bed. He would get up and go lock the door so she could not get out. V.M. stated that sometimes Larry would take the dog leash and put it around a drawer by his room and the other end around the door so she could not get out. V.M. stated that one time she tried to break the leash, but could not. She tried to get her mom's attention by kicking the door, but was unable to.

Pat then asked V.M. what happened when Larry got on top of her. V.M. stated that he would start to go up and down. Pat asked V.M. what happened to her clothes and V.M. stated that he would take them off. She then stated that Larry would take his clothes off and V.M. kept her clothes on. V.M. then stated that when he went up and down, she would try to push him off of her and when she was able to get away from him, she would run outside and then run all over. She stated Larry would then put his clothes on and come outside and try to talk to her.

Pat asked V.M. if when Larry was going up and down on top of her if there were any of his body parts touching hers. She stated, yes. When asked what kind of parts, she stated his privates were going up and down on her legs. Pat asked V.M. if she could feel that. She stated that is why she was trying to push away from him. She stated sometimes, when she would get out and get away, she would run to her brother's room or she would go to her room and hide under her bed.

Pat asked V.M. if this happened one time or lots of times. V.M. responded, "Lots of times". Pat also asked V.M. if her mom knew about this. She stated her mom did not know until she recently told her. V.M. stated that she was always scared to tell her mom about it. She stated that this has been going on for approximately six years. She believes it started when she was approximately three years old because that's when Larry moved in. V.M. advised that she didn't remember a time when Larry didn't do this.

Pat then asked V.M. again about his privates touching her legs. V.M. identified male and female private parts on anatomical drawings. Pat then asked V.M. if when Larry moved up and down if anything happened to his private. She stated that there would be stuff coming out of it. Pat asked V.M. what kind of stuff. She replied, "gooey stuff". Pat asked V.M. where this stuff went. V.M. stated it spread all over her legs and then Larry would get up and get a towel and wipe it off. V.M. stated that sometimes, Larry would lift up her pant leg and put the stuff on her skin, but he washed it off afterwards.

Pat asked V.M. if she had talked to her mom about other things that had happened. V.M. stated that sometimes she would have a sleepover with her friend and after her friend fell asleep, she stated her mom would make a tent for her and her friend to sleep in. After her friend fell asleep, Larry would wake her up and take her to his room and say, "You wanna do it." She stated that her mom would even be in the bed at that time. V.M. stated that Larry would make her mother get out of bed and go sleep in the reclining chair so he could do it to her. V.M. stated that he would do all the stuff she had previously explained. Pat then asked her if when he said, "Do you want to do it?" what did he mean. V.M. stated that sometime, he would lay beside her and sometimes she would lay toward him.

Pat asked V.M. when he was toward her what part of her body would get touched and V.M. pointed to the diagram and pointed to the breasts and she stated he would sometimes rub her back. Pat asked if anything happened to her butt. She stated that he would also rub it sometimes. Pat asked V.M. about her private and if anything happens to her private. V.M. stated that he rubs it with his fingers. Pat asked V.M. when he rubs her private where her clothes are. She stated that they are still on, that he just goes inside her pants and up her shirt when he does it.

Pat asked her private feels when he rubs it and she advised, uncomfortable. V.M. went onto state that sometimes, he touches and then took her hand and proceeded to scratch her fingers on the chair demonstrating how he touches her private with his hands. She also stated that he touches her on the inside and on the outside of her private. Pat asked her if when he puts his finger on the inside if he moves it around, leaves it still, or something else. V.M. stated that he moves it in and out. Pat then asked about when he rubs her butt if anything would happen. She stated, no, he would just move it with his whole hand. V.M. stated that it hurt to use the restroom afterward.

Pat asked V.M. if Larry's private ever touched her anywhere besides her leg. V.M. stated that he would put it on her cheek and make gushy stuff come out again on her face. V.M. stated that sometimes, he would try to make her suck on it, but she would keep her mouth shut and would not suck on it. She advised that he would rub it against her cheek sometimes.

V.M. described that sometimes, she would be lying down and he would stand up and put his private towards her face and she would push it back. V.M. stated that she would then have to take it with her hands and move up and down in order to make the stuff gush out of it. When the stuff came out, it would go over her hands and then he would get a towel and would take his boxers and wipe his boxers off. Pat then asked again what she would do when Larry tried to make her suck on his private. She stated she would just push him off. She stated that she would get off the bed and go watch TV and about a half-hour later, he would come and get her, take her back to the room, and try to make her do it again.


V.M. stated that things have been happening since she was 3-4 years old. She advised that when she was 4, she had casts on her legs and she could remember Larry kissing her all over her body a lot. She stated that he would not get on top of her because it would break open the cast. Pat asked V.M. when the last time was that something happened. V.M. stated it was during the daytime and she couldn't remember why she was home. She stated that she didn't remember everything he did, but he would do all the things she had previously stated. V.M. said that Larry pushed her head under the covers to

try to get her to suck on his privates and goeey stuff got on her lips. V.M. stated that she would have to stay in bed with him until he fell asleep, at which time, she could slip out of bed. V.M. also spoke of a time when Larry took her downstairs and sat in a chair like a recliner and tried to make her suck on his private. V.M. stated that she had to suck on Larry's "man boobs."


V.M. stated that while Larry was moving his private up and down on her that he would start breathing kind of deep and kind of weird. V.M. also stated that she forgot to tell Pat that Larry rubs his private against her butt and he would get the white stuff all over her bottom and would then wash it off with a towel. Pat asked V.M. how many times this would happen. She stated that it happened about the same. Pat asked how and where this occurred. V.M. stated it happened on the bed and that she would be turning to get away from Larry or he would roll her over onto her stomach to get to her. She stated that sometimes, he would pull her pants down a little to get to her bottom. V.M. stated that he kind of made it go inside of her butt. Pat asked her how that felt and she said it hurt really bad. Pat asked V.M. what happened when she told her mom. She stated her mom was really upset and that she took V.M. over to her friend's house, and told V.M. to stay there until Larry left. Pat asked V.M. what made her decide to tell her mom at that point. V.M. stated that she just wanted it to stop. She was afraid to tell her mom. Pat asked her why she was afraid. V.M. stated that she thought she would get in trouble. V.M. stated that her mom made Larry move out.

Larry consented to an interview with affiant. Upon arrival at the Fort Wayne Police Department, Larry was read his Advice of Rights. He indicated that he understood what his Rights were and Larry then read the Waiver of Rights statement aloud and advised that he was going to make a statement without his attorney present. Affiant asked Larry about his relationship with V.M.. He stated that the two of them have a good relationship and they are very, very close. Affiant asked Larry if V.M. makes up stories or lies about things. He stated, no, that she is very honest and very smart. Affiant then confronted Larry with the allegations against him and what V.M. had stated that he had done. Larry denied everything this detective asked him in reference to inappropriate touching of V.M.. This concluded the interview with Larry Gonzalez.

The Affiant believes the witnesses to be credible and reliable.


